## Conference Call Agenda/Minutes

- **Roll Call**

Quorum established.
- **Approval of Minutes from 12-16-2019 and 1-30-2020**

Motion to approve the December minutes made by Jean Hall (KY); seconded by Sherry Green (Sherry Green & Associates). Unanimously approved.

Motion to approve the January minutes made by Jean Hall (KY); seconded by Sherry Green (Sherry Green & Associates). Unanimously approved.
- **Subcommittee Goals for 2020**

Kevin Borchert (NE) mentioned that the PMIX Executive Committee is still reviewing the goals and will be made available shortly.
- **Update from Patient Matching Working Group**

Kevin Borchert (NE) stated that the group continues to have discussions. The group will identify metrics around data quality and patient matching as well as how to calculate those metrics. He mentioned that Nebraska will be employing improved probabilistic matching techniques for their PDMP and EHR data. He added that NeHii has hired Naresh Sundar Rajan from the Utah PDMP and he will start in March. Jean Hall (KY) stated that Kentucky is working on their analytics for out of state patients within the PDMP data. She indicated that she is willing to share the results when completed.
- **Update from PMIX Schema Working Groups**

Jean Hall (KY) described the efforts of the two working groups. Work Group 1 is updating the schema to the latest version of NIEM and ASAP 4.2B. Work group 2 has identified patient alerts and sent the recommendations to Work Group 1 to add to the schema. Work Group 2 will also develop a code table for the alerts. She added that when the work groups have completed their work, it will be provided to the PMIX Operations Subcommittee to vote on whether or not to send to the PMIX Executive Committee. At that point, the PMIX Executive Committee will draft a proposal to update the PMIX National Architecture which will be posted for review and comment. The complete process to change the PMIX National Architecture is on the PMIX webpage on the TTAC website. She anticipated that the work groups should have their work completed within the next 30 days.

Kevin Borchert (NE) mentioned that efforts are underway to develop a new logo for the PMIX Standards Organization as well as revise the content and organization of the PMIX website. TTAC stated that samples should be available on the next subcommittee conference call.
