## Conference Call Agenda/Minutes

### ➤ Roll Call

Quorum established.

### ➤ Approval of Meeting's Minutes from 3-17-2021

Motion to approve the minutes was made by Stan Murzynski (PA); seconded by Eric Grace. Unanimously approved.

### ➤ Best practices in EHR integration/interstate data sharing queries

- Updates to user roles/permissions (Rodd Kelly, Nilu Kundagrami, Clay Rogers)
- Approval of document

Subcommittee decided to copy in the PMIX Health User Roles from website into this document. Motion to approve the revised document and send to the PMIX Executive Committee was made by Stan Murzynski (PA) and seconded by Depris Price (NC). Approved with one abstention by Chuck Bedel (DrFirst) who had not reviewed the document at this point. TTAC will make the revisions and send document to subcommittee members and PMIX Executive Committee.

### ➤ GOAL: Hub to Hub Interoperability - Document the previous work that proved the feasibility of hub-to-hub interoperability. Consider whether this should be a standard.

Ron Larsen (UT) introduced the topic and asked subcommittee members for comments. Clay Rogers (Appriss) stated that the differing encryption/decryption methods used by the hubs would make accomplishing hub interoperability difficult. Stan Murzynski (PA) suggested that an intermediary between the hubs could be developed which would have the encryption keys for both hubs; the SRS could manage the keys. Clay Rogers (Appriss) added that this would require development by each hub to accommodate this and necessitate a review of states' and hubs' agreements. Julio Mendoza (KY) suggested that the subcommittee should develop list to determine the return on investment for the hub interoperability effort.

The subcommittee decided to table this goal until more research is completed. Ron Larsen (UT) asked subcommittee to send their thoughts and pros/cons of hub interoperability to TTAC prior to the next meeting for future discussions. TTAC will research previous discussions on this topic and provide to subcommittee.
