Jean Hall (KY) reviewed the latest version of the interoperability diagram as a refresher for the group. This diagram is being created for a more technical audience; a layman's version will be developed.

Diagram edits discussed:

- slide 3 edit the last sentence of hub definition; change 'NEHII' to 'CyncHealth'
- slide 4 edit spelling of 'Cynchealth'
- slide 5 remove PastRx; edit definition of PDMP system to include 'shares data with integration facilitators....' and add more of the PDMP functions; add Bamboo Gateway
- slide 14 add state and organization authorities under 'Authorization'; add user role to 'Validation'; rearrange items to mirror flow of information
